CRIMINAL CODE AT THE CONSTITUTIONAL COURT

BANJA LUKA, 19 SEPTEMBER 2023



On 19 September 2023, the team of legal experts, appointed by Umbrella, submitted to the Constitutional Court of Republic of Srpska, the initiative (inicijativu) demanding the assessment and evaluation of Criminal Code amendments of Republic of Srpska that de facto criminalized defamation/libeling.

INVESTIGATIVE STORIES AND TEXTS COVERING THE ISSUE OF "CRIMINALIZATION OF DEFAMATION/LIBELING IN REPUBLIC OF SRPSKA"

In cooperation with Umbrella members and their support, we managed to post five investigative stories regarding the issue of "Criminalization of defamation/libeling in Republic of Srpska". Let us together make thorough analysis, interviews and detailed investigations that reveal and expose in what way shall the re – criminalization of defamation/libeling make impact on media liberties and freedom and public expression in BiH.



In first investigative reporting text, posted by Portal Capital, the authors problematized the ban of public releasing of "personal character list", in regard with most recent Criminal Code amendments: Kazna za novinare za objavu matičnog broja.

In second investigative text, posted by Interview.ba, legal challenges and concrete solutions, regarding the protection of both female and male journalists, have been subject to detailed analysis: KRIMINALIZACIJA KLEVETE Kako zaštititi novinare, bez suvišnog zašto?





In third investigative report text, posted by Inforadar, legal instruments used to protect journalists and freedom of speech have been investigated: NOVINARSKA PRAVA I KLEVETA: Mehanizmi zaštite novinara i slobode govora.

In fourth investigative text, posted by Spin- portal, the authors problematized the number of legal lawsuits concerning the defamation/libeling in the city of East Sarajevo: Tužbi za klevetu nisu pošteđeni ni novinari iz istočnog dijela Republike Srpske.





In fifth invetigative text, posted by Hercegovina info, the authors investigated what may happen when someone press charges against you based on defamation/ libeling and you happen to be in Herzegovina, Serbia or Croatia: 30-ak prijava zbog klevete u RS-u. Evo što se događa ako vas netko prijavi, a vi ste u Hercegovini, Srbiji ili Hrvatskoj.

23 November 2023

Training for Umbrella members regarding the reporting adopted to Criminal Code amendments on defamation/libeling in Republic of Srpska in order to have Umbrella members as much as possibly protected while they tailor and make their investigative texts. Training was supported by BMAPF project financed by the USAID and was implemented Internews in the Balkan. Senad Pećanin, a lawyer and experienced professional journalist and former editor of Dani, a local weekly magazine from Sarajevo, held and ran this this training.



12 September 2023

Training for Umbrella members from Sarajevo, Mostar and Trebinje with strengthened and reinforced capacities of journalists as well, including the editing office and need to advance physical and digital safety. This training was also conducted in cooperation with KRIK from Serbia and supported by BMAPF Internews program



11 September 2023., Banjaluka

Training for Umbrella members from Banjaluka with 22 journalists having their capacities strengthened and reinforced in relation with safety culture development branch, including security protocols that would enable safer job performance for all journalists. Training was held in cooperation with KRIK from Serbia and supported by BMAPF Internews program.
